## **Personal data that we process**

Tubien, Artist with Camera processes your personal data by using our services and / or by providing this information to us.

Below is an overview of the personal data we process:

- E-mail address

## **Special and / or sensitive personal data that we process**

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardian.

However, we can not check if a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, to prevent data about children being collected without parental consent. ## **With what purpose and on what basis we process personal data**

## **Automated decision-making**

Tubien, Artist with Camera decides not on the basis of automated processing decisions about matters that (significant) may have consequences for people. These are decisions that are taken by computer programs or systems, without a person (for example a Tubien, Artist with Camera employee) sitting between them.

### **How long we store personal data**

Tubien, Artist with Camera does not store your personal data longer than is strictly necessary to achieve the goals for which your data is collected.

### **Sharing personal data with third parties**

Tubien, Artist with Camera provides exclusively to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

### **Cookies, or similar techniques, that we use**

Tubien, Artist with Camera does not use cookies or similar techniques.

### **View, modify or delete data**

You have the right to view, correct or delete your personal data. You can do this yourself through the personal settings of your account. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by our company and you have the right to data portability. This means that you can submit a request to us to send the personal information we hold to you or another organization mentioned by you in a computer file.

Do you want to use your right of objection and / or right to data portability or do you have other questions / comments about the data processing? Send a specified request to [mailme@tubien.nl](mailto:mailme@tubien.nl).

In order to ensure that the request for access has been made by you, we ask you to send a copy of your identity document with the request. Make your passport photo in this copy, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black. This is to protect your privacy. Tubien, Artist with Camera will respond as soon as possible, at least within four weeks, to your request.

Tubien, Artist with Camera also wants to point out that you have the opportunity to submit a complaint to the national supervisory authority, the Dutch Data Protection Authority. This can be done via the following link:
